INFORMATION WE COLLECT

You may voluntarily provide us with information, including:

Your name, email address, mailing address, telephone number, date of birth, profile name, profile photo, picture, height, weight, occupation, physical characteristics, ethnicity, personal interests, relationships and preferences, whether part of the POZ (HIV positive) community, residence information, listing address and details for residential and other properties, rooms, accommodations, third party social networking or other service user names, and a profile name and password that you create to register to use our website;

Although however, information such as your first name, profile photo, current sexual status, and other some other items will be required to access and utilize our website. For the safety, discreet nature of our group, this stature will apply. Do Not Track. At this time, we do not respond to "do not track" signals sent from Web browsers or other mechanisms that provide users the ability to exercise choice regarding the collection of personally identifiable information about a user's online activities over time and across third party Internet services.

SECURITY

Although we use administrative, technical and physical measures to help protect the information you submit via the Service from accidental or unlawful destruction, loss or alteration and from unauthorized access, use, or disclosure, we cannot guarantee its absolute security.
